**OFFICIAL NOTIFICATION TO MEMBERSHIP
REGARDING PROPOSED MERGER OF CHESTER LODGE #1629
WITH MURPHYSBORO LODGE #572**

Elks Lodge #572 Members All: You are hereby officially notified of the proposed merger of Chester Elks Lodge #1629 with Murphysboro Lodge #572. Please find, included in this bulletin, a copy of Resolution adopted by the Trustees of Lodge #572 on 12 April, 2006, presented to the Lodge Floor on 19 April, 2006, and forwarded to the Exalted Ruler of Chester #1629.

Of the various options available to the Chester Lodge, the Officers and Trustees of said Lodge, pursuant to Grand Lodge Statues, Chapter 11, Section 11.060, have expressed their desire to merge with Murphysboro #572, therefore providing their members, who so desire, a smooth non-penalty, non-fee transition into their closest, contiguous-border, Illinois Lodge. (See esp. paragraph 2 of Resolution, stating the reasons for merger request.) A similar resolution for merger

into Murphysboro #572 has been adopted by the Trustees of Chester #1629, and therein presented upon their Lodge floor, and to the Exalted Ruler of #572.

Chapter 11, Section 11.060 requires the resolutions proposing any merger be read on the floor of both lodges and that notification of said action be sent to all members of both Lodges. After notice is given, and appropriate length of time has passed, the merger is to be brought on the floor of both Lodges for a vote of the members attending the regular meeting of each respective Lodge on the night on which the vote on the Resolution has been scheduled.

The Resolution for merger of Chester Lodge #1629 with Murphysboro Lodge #572 is scheduled for a vote at the regular Lodge #572 Meeting on Wednesday, June 7, 2006, commencing at 7:30 pm. A

two-thirds vote of those present will be necessary to pass the resolution. (The same requirement will apply to the vote taken on the Resolution by the members of Chester #1629.)

If both the members of our Lodge and the members of the Chester Lodge pass the Resolution, it will be forwarded to the Grand Exalted Ruler and our state sponsor, the Hon. Robert J. Sabin. If the Resolution is endorsed by the Grand Exalted ruler, it will then be presented to the Board of Grand Trustees of the Benevolent and protective Order of Elks for their consideration. If passed by the Board at the Grand Lodge Convention in Orlando, Florida, in July, 2006, Chester #1629 will surrender its Charter, and Chester members in good standing will therein be automatically issued membership cards from Murphysboro #572.

RESOLUTION

WHEREAS, the Board of Trustees of Murphysboro Elks Lodge #572 has been advised that Officers and Trustees of Chester Elks Lodge #1629 have met with South District Officers, Illinois Elks Association Representatives, and the Exalted Ruler of Murphysboro Lodge #572, and:

WHEREAS, said Officers of Chester Elks Lodge #1629 have expressed their desire to relinquish their Charter and merge with Murphysboro Lodge #572, as a result of their concerns regarding the Chester Lodge's declining financing, declining membership, and especially declining interest of the existing membership to provide for the leadership necessary for the continuation of the Lodge and the Lodge's ability to effectively carry out the many programs of the Benevolent and protective order of Elks of the United States of America, and;

WHEREAS, such merger of Chester Elks Lodge #1629 with Murphysboro Elks Lodge #572 is allowable, pursuant to Chapter 11.060 of the Grand Lodge Statutes, and;

WHEREAS, the Board of Trustees of Murphysboro Elks Lodge #572 desires to accommodate the request of the Officers and Board of Trustees of Chester Elks Lodge #1629 and therein provide the Chester Lodge's Members a positive option for the continuance of their Membership in the Benevolent and Protective order of Elks of the United States of America, as afforded by Chapter 11.060 of the Grand lodge Statutes;

NOW THEREFORE IT BE RESOLVED by the Board of Trustees of Murphysboro Elks Lodge #572 that this Board of Trustees does hereby recommend and propose the Merger of Chester Lodge #1629 with Murphysboro Elks Lodge #572, and that a Certified Copy of this Resolution be forwarded to the Exalted Rulers of Murphysboro Elks Lodge #572 and of Chester Elks Lodge #1629.
