#### PROGRESS REPORT ON MORTGAGE REDUCTION

The Officers of Lodge #572 would like to extend their sincere appreciation to so many of our members who, along with their timely dues payments, have graciously sent in additional donations for our Bank Mortgage reduction! While last year's contributions were excellent, this year's pace has been even better - as of calculations totaled on 4/8/16, we had received \$3,331.50 in extra loan reduction contributions from some 147 of you, our supportive members. Then, on April 21, we paired this amount with our regular, monthly mortgage payment of \$2,000.00, and an additional \$1,000.00 from Queen of Hearts Raffle proceeds, such that a total of \$6,331.50 was paid. Result? Our outstanding loan amount is now down to \$6,537.85! (And, extra contributions continue to accompany dues payments.) YOU, our members, are making it happen!

## Mortgage Burning Party On The Horizon

The Lodge mortgage payment is \$2,000.00 per month (\$24,000.00 per year). However, thanks to a profitable club room, hall rentals, video gaming, annual Luck of the Lodge raffle, generous donations from our members, and now the Queen of Hearts, we have been paying roughly \$16,000.00 in extra mortgage payments for the last three years. We anticipate paying off the mortgage in the next two or three months.

Once the mortgage is paid off, we can then pay off remaining bonds held by our members, an interest-free bond from the Oldenhage Fund, and an interest-free loan from a member totaling just under \$58,000.00. Over the past year, we have paid off one \$5,000.00 bond held by members.
